Foreword to sixth edition

The Royal Marsden Hospital Manual of Clinical Nursing Procedures has become a legend. When I look back at the first edition, an internally produced procedure manual just for use at The Royal Marsden, it is quite amazing to think that 'the manual' has become such an important source for nurses everywhere. The fifth edition, in particular, has enjoyed enormous success. Introduction

There is an expectation from patients that the nursing care they receive will be based on the best available evidence. Clinical procedures are a fundamental aspect of nursing care so it is essential that they are evidence based. This sixth edition of *The Royal Marsden Hospital Manual of Clinical Nursing Procedures* includes the clinical procedures, and the latest evidence underpinning the fundamental nursing care of any sick adult, whatever their diagnosis.

The findings from a survey of readers, particularly student nurses, informed the writing of this edition. There were a number of requests for additional chapters relating to a broad variety of aspects of nursing practice. We considered all of these and have included those that relate to the clinical expertise or practice of nurses within The Royal Marsden NHS Trust, an international cancer hospital.

A different approach has been taken to the preparation of the sixth edition of this manual: led by clinical experts, nurses in clinical practice have been involved in reviewing the latest evidence and testing the revised procedures in practice. This has provided professional development opportunities for junior staff and practical experience of identifying and then implementing evidence in practice. We hope that it has also acknowledged and recognized that important aspect of generating evidence in nursing: using the evidence that comes from practice (Kitson *et al.* 1998).

All chapters have been reviewed and some expanded to encompass new material including the legislative changes that have impacted on nursing roles. Context of care (Chapter 1) explores the concept of clinical governance in respect of clinical nursing practice, and includes an expanded section about the consent to examination and treatment in light of the NHS Reform and Health Care Professions Act (2002). A new chapter, Communication and assessment (Chapter 2), looks in depth at the process of patient assessment, emphasizing its importance in relation to carrying out clinical nursing procedures. Aseptic technique (Chapter 4) now includes a procedure for hand washing. Breast care (Chapter 6) now incorporates a section about seroma drainage. Drug administration (Chapter 9) includes an expanded section on nurse prescribing. Central venous pressure measurement has been moved to Observations (Chapter 25); a section on peak flow measurement has also been added to this chapter.

In this edition the chapters have been reorganized, grouping together those addressing similar aspects of care: Drug administration; Elimination; Observations; Pain management and Personal hygiene, with the intention that information can be found more easily.

This edition continues the work that began 20 years ago, providing a practical resource for nursing practice. The format follows that of the preceding editions with only a few changes.

Every chapter begins with **definition**: this concisely defines the aspect of care addressed by the chapter.

This is followed by a **reference material section** consisting of a review of the literature and other relevant material. If available, the related research findings have been presented. If there is no research evidence available the procedures have been based on experience and systematic reviews.

The procedure guidelines begin with a list of the equipment needed, followed by a detailed step-by-step account of the procedure and the rationale for the proposed action. All relevant procedures begin with the action 'Explain and discuss the procedure with the patient', the rationale for this being 'to ensure the patient understands the procedure and gives his/her valid consent'. Gaining consent is an integral part of the person-focused approach to care, a core principle of nursing practice at The Royal Marsden Hospital. This is discussed further in Chapter 1.

Some chapters also include a **problem-solving section**. This lists the problems that may occur with a procedure, their possible causes and suggestions for their resolution and prevention.

The references and further reading at the end of the chapter indicate the sources from which information has been drawn to write the reference material and develop the procedures. It is also available to assist the reader if they want to study the subject in more depth. The further reading lists have been substantially revised for this edition; only publications from the past 10 years have been included, unless they are seminal texts or the only material available.



This book is intended as a reference and resource, not a replacement for practice-based education. None of the procedures in this book should be undertaken without prior instruction and subsequent supervision from an appropriately qualified and experienced professional.

We hope that The Royal Marsden Hospital Manual of Clinical Nursing Procedures will continue to be a resource and be a contribution to 'continually improving the overall standard of clinical care, whilst reducing variations in outcomes ... as well as ensuring that clinical decisions are based on the most up to date evidence of what is known to be effective' (NHSE 1999, p. 3).
