# BRITISH JOURNAL OF INDUSTRIAL RELATIONS

## Notes for Contributors

1. Pressure on Journal space is considerable, and brevity is requested. Most papers will contain less than 7000 words, but this figure may be exceeded in exceptional cases. Short papers (less than 2500 words) are welcome. Where necessary, a short paper should be supplemented by a full report available on request from the author; the Editor will wish to see this full report before accepting the short paper.
2. Papers submitted for publication will normally be scrutinized by two independent referees as well as by one of the Editors. A decision about acceptability is usually possible within two months. Papers will normally, but not always, be published in order of their final acceptance.
3. Submission of a paper implies that it has neither been published elsewhere nor is under consideration by another journal and that it is the product only of the author(s) cited on the title page. The Editors have a two-year limit for re-submission of manuscripts.
4. In preparing material for submission or re-submission authors should follow these guidelines:
  - (a) Contributions must be typed in double spacing with wide margins and on one side only of each sheet. Sheets must be numbered. Four good copies should be sent of any typescript and any communications attached. Send an electronic version in one integrated file to s.roesch@lse.ac.uk
  - (b) Tables should be typed in double spacing on separate sheets. Each should have a self-explanatory title and should be comprehensible without reference to the text.
  - (c) Figures should also be on separate sheets, numbered sequentially, and each identified on the back with the title of the paper. They should be carefully drawn, larger than intended size, suitable for photographic reproduction and clear when reduced in size. Tints and complex shading should be avoided. Lettering must not be put on the original drawing but upon a copy to guide the printer. Captions should be listed on a separate sheet.
  - (d) All articles should be preceded by an Abstract of around 100 words (less in the case of a short paper), giving a concise statement of the intention, results and the conclusions of the article.
  - (e) Bibliographical references in the text should quote the author's name and date of publication thus: Booth (1987). Multiple citations should be given alphabetically rather than chronologically: (Sako 1990; Thurley 1960; Wood 1980). If a work has two authors, cite both names in the text throughout: Dunn & Gennard (1984). In the case of references to three or more authors, use the et al. form on all occasions except in the reference list.
  - (f) References cited in the text must appear in a list at the end of the article. The list should be typed in double spacing in the following format:

Booth, A. (1987). Extra-statutory redundancy payments in Britain. *British Journal of Industrial Relations*, 25: 401–418.

Dunn, S. and Gennard, J. (1984) *The Closed Shop in British Industry*. London: Macmillan.Note that journal titles are cited in the reference list without abbreviation.
  - (g) Presentation of complex statistical tables should be avoided. It is generally better to provide descriptive accounts of data in the main text and where necessary include a statistical appendix.
  - (h) Authors are required to avoid the use of sexist or racist language.
  - (i) If a long title is necessary (more than 60 letter spaces), a short title should also be given for use as a running headline to the article.
  - (j) Footnotes should be avoided.
  - (k) The approximate number of words of the article must be written clearly on the opening page of each manuscript.
5. It is the policy of the BJIR to conduct "blind" reviews, where referees do not know the identity of the authors. Authors should submit two title pages, one with their name/s included and the other without. When referring to their own work, both the name in the text and the full entry in the references should be replaced by three Xs, i.e. 'XXX'.
6. Proofs are sent to authors for correction of typesetting errors *only*. Authors will be charged for any other corrections. Two complimentary copies of the journal are supplied to each author. Offprints of each article may be ordered on a form supplied with the proofs.
7. To protect authors and journals against unauthorized reproduction of articles, The London School of Economics requires copyright to be assigned to itself and Blackwell Publishers jointly as publisher, on the express condition that authors may use their own material at any time without permission. On acceptance of a paper submitted to the Journal, authors will be requested to sign an appropriate assignment of copyright form. The author's consent will be sought before any applications to reproduce material in commercially-published anthologies are granted. Fees are waived for photocopying of isolated articles for non-profit classroom or library reserve use by instructors and educational institutions.
