Instructions for Authors

Kidney International will consider the publication of any original manuscript that deals with either clinical or laboratory topics of relevance to nephrology. All manuscripts must be contributed solely to *Kidney International* and all studies must be documented completely by reference to the literature and a thorough description of the experimental method. Substantive portions of any manuscript must not have been published elsewhere except in abstract form. All authors must sign a letter when submitting a manuscript signifying their agreement with the contents of the paper.

Methods or findings that will substantially and immediately affect research or clinical practice will be considered for publication as a Rapid Communication. The words "Rapid Communication" and the category chosen must appear at the top left corner of the title page. These manuscripts should be no longer than 1500 words and contain no more than 35 references and no more than 4 figures or tables. Organization of Rapid Communications should be the same as for regular manuscripts.

Technical Notes of no more than 1500 words in length will also be considered for publication. Examples of appropriate subject matter include descriptions of new laboratory or clinical methods, new apparatus, or critical modifications of established techniques. Organization of Technical Notes should be the same as for regular manuscripts except that section headings should be omitted.

Letters to the Editor will be considered for publication, subject to editing. Letters must contain information critical to a certain area or must be confirmatory of data recently published in *Kidney International*. Letters must not exceed 250 words, and contain no more than 4 references and 1 figure or table.

Copyright: Submission of a manuscript implies that the work described has not been published before (except in the form of an abstract or as part of a published lecture, review, or thesis); that it is not under consideration for publication elsewhere; that its publication has been approved by all coauthors, if any, as well as by the responsible authorities at the institute where the work has been carried out; that, if and when the manuscript is accepted for publication, the authors agree to automatic transfer of the copyright to the International Society of Nephrology; that the manuscript will not be published elsewhere in any language without the consent of the copyright holders; that written permission of the copyright holder is obtained by the authors for material used from other copyrighted sources; and that any costs associated with obtaining this permission are the authors' responsibility.

Manuscript Submission Instructions: Manuscripts must be submitted online. For complete detailed instructions on uploading your manuscript, please read the submission instructions on the *Kidney International* Web site (http://ki. manuscriptcentral.com). Any major word processing software may be used, and both DOS-based and Macintosh operating systems are acceptable. Authors with no Internet connection should contact the Editorial Office.

The original manuscript must be accompanied by a letter of submission giving authors' names, corresponding author's address, telephone and fax numbers and e-mail address, manuscript title, names and addresses of 4 potential reviewers, and suggested category.

We require, as a condition of consideration for publication, registration in a public trials registry. Trials must register at or before the onset of patient enrollment. This policy applies to any clinical trial starting enrollment after January 1, 2006. For trials that began enrollment before this date, we require registration by April 1, 2006, before considering the trial for publication.

We define a clinical trial as any research project that prospectively assigns human subjects to intervention or comparison groups to study the cause-and-effect relationship between a medical intervention and a health outcome. Studies designed for other purposes, such as to study pharmacokinetics or major toxicity (e.g., phase 1 trials) are exempt.

We do not advocate one particular registry, but registration must be with a registry that meets the following minimum criteria: (1) accessible to the public at no charge; (2) searchable by standard, electronic (Internet-based) methods; (3) open to all prospective registrants free of charge or at minimal cost; (4) validates registered information; (5) identifies trials with a unique number; and (6) includes information on the investigator(s), research question or hypothesis, methodology, intervention and comparisons, eligibility criteria, primary and secondary outcomes measured, date of registration, anticipated or actual start date, anticipated or actual date of last follow-up, target number of subjects, status (anticipated, ongoing or closed) and funding source(s).

Six weeks before you move, please let the Publisher (Non ISN member subscribers) or the Society (ISN member subscribers) know what your new address will be. Be sure to supply the Publisher or Society with both your old and new addresses and zip codes, and the address label from your current issue.

Registries that currently meet these criteria include (1) The registry sponsored by the United States National Library of Medicine (*www.clinicaltrials.gov*); (2) The International Standard Randomised Controlled Trial Number Registry (*www.controlled-trials.com*); (3) The Cochrane Renal Group Registry (*www.cochrane-renal.org/trialsubmissionform.php*); (4) The National (United Kingdom) Research Register (*www.update-software.com/national/*); and (5) European Clinical Trials Database (*http://eudract.emea.eu.int/*).

All manuscripts will be read by the Editor(s) and reviewed further by at least two reviewers. The entire manuscript must be double-spaced, including the abstract, footnotes, references in order of citation, figure legends, tables, and table legends. All manuscripts should include (1) title page (which should include a title of no more than 115 characters, telephone and facsimile numbers, and an e-mail address of the corresponding author), (2) short title page, (3) abstract, (4) body of paper, (5) acknowledgments and address for reprint requests, (6) references, (7) tables, (8) figure legends, and (9) figures. An abstract, not to exceed 250 words in length, must be submitted. The complete title of the paper should be repeated at the beginning of the narrative. The abstract should consist of four paragraphs, labeled Background, Methods, Results, and Conclusion. At least 3 key words should be given. One set of glossy figures and two hard copies of the manuscript, as well as a disk containing the final version of the paper in Microsoft Word or Word Perfect format (not PDF) will be requested upon acceptance of the paper. To ensure the finest quality of figures, whether line drawings, half-tones, or color prints, the author should supply the figures as glossy photographs. Manuscripts should be consistent in style, spelling, and use of abbreviations. Slang, medical jargon, and obscure abbreviations are to be avoided. Abstract citations must be incorporated parenthetically in the text and should not be included in the reference list. All manuscripts and figures are subject to copy editing. Reporting must be concise. A charge of U.S. \$65 will be issued for each journal page. A charge of U.S. \$50 will be made for each individual half-tone or full plate exceeding two in number. Color figures are \$1500 per page. Authors are expected to pay all publication costs associated with their article, or to make prior arrangements for sponsorship of these costs

Reference style: The form of the references should include end pagination, but the number, day, or month of the issue should be omitted. A maximum of four authors should be cited. For more than four authors, cite three and insert et al. Please do not use all capital letters, rather imitate the samples given below. Our typesetting software sets the typeface into journal style, but it is crucial that the citation is precisely in order. Abbreviations for journal titles should follow *The List of Journals Indexed in Index Medicus*. Internet users may obtain a listing of journal abbreviations by accessing http://medscape.com. The following examples demonstrate correct style:

Journal articles: Surname and initials of author(s), title, journal, volume, inclusive pages, year. **Example:** Fan SL-S, Almond MK, Ball E, et al: Pamidronate therapy as prevention of bone loss following renal transplantation. *Kidney Int* 57:684–690, 2000

Supplement articles: Surname and initials of author(s), title, journal, volume number, supplement number in parentheses, inclusive pages, year. **Example:** Fogo AB: Glomerular hypertension abnormal glomerular growth, and progression of renal diseases. *Kidney Int* 57(Suppl 75):S15–S21, 2000

Books: Surname and initials of author(s), title and subtitle, edition (other than first), city, publisher, year, volume (where applicable), inclusive pages (if specific pages are being cited). **Example:** Lameire N, Mehta RL (editors): *Complications of Dialysis*, New York, Marcel Dekker, Inc., 2000, 875 pp

Articles in books: Surname and initials of author(s), title of article, chapter number, title of book, volume, editor, edition (other than first), city, publisher, year, inclusive pages. **Example:** Weidner N, Buckalew VM Jr: Sickle cell anemia, sickle cell trait, and polycythemic states, in *Renal Pathology* (vol 2), edited by Tisher CC, Brenner BM, Philadelphia, JB Lippincott Company, 1989, pp 1417–1436

To facilitate prompt publication of accepted manuscripts, page proofs only will be sent to the corresponding author for correction. Authors may purchase reprints at prices furnished with the page proofs. Failure to return page proofs and all related documentation, including page charge forms, may result in a delay in publication.

Author material archive policy: Unless specifically requested, Blackwell Publishing will dispose of all hard copy or electronic material submitted two months after publication. If you require the return of any material submitted, please inform the Editorial Office or Production Editor.
