

## Notes for Contributors

**Manuscripts** should be sent by e-mail or post to:

Articles should be double spaced, with ample margins, and bear the title of the contribution, name(s) of the author(s) and the address where the work was carried out. The full contact details (including e-mail address) of the author(s) for correspondence should be included. All pages should be numbered. We would like to encourage authors to make sure that the language used does not convey any unintended bias.

**Length:** The preferred length for articles is 7000-9000 words. (If you wish to submit a shorter or longer one, please contact the journal editors. They will be happy to advise).

**Tables and captions to illustrations.** Tables must be presented on separate pages and not included as part of the text. The captions to illustrations should be gathered together and also typed out on a separate sheet. Tables should be numbered by Roman numerals, and figures by Arabic numerals. The approximate position of tables and figures should be indicated in the manuscript. Captions should include keys to symbols.

**Figures.** Please supply one set of artwork in a finished form, preferably electronically, suitable for reproduction. If this raises problems, please contact the editors.

**References** should be indicated in the typescript by giving the author's name, with the year of publication in parentheses. If several papers by the same author and from the same year are cited, a, b, c, etc. should be put after the year of publication. The references should be listed in full at the end of the article in the following standard form:

*For books:* TEICHLER, U. (2007) *Higher Education Systems. Conceptual Frameworks, Comparative Perspectives, Empirical Findings* (Rotterdam, Sense Publishers).

*For articles:* KEHM, B. M. (2007) Quo vadis doctoral education? New European approaches in the context of global changes, *European Journal of Education*, 42, pp. 307-319

*For chapters within books:* KEATING, D. (1996) Habits of mind for a learning society, in: DAVID R. OLSON & NANCY TORRANCE (Eds) *The Handbook of Education and Human Development* (Oxford, Blackwell Publishers).

Titles of journals should *not* be abbreviated.

**Referencing software:** There are several software packages available to help authors manage and format the references and footnotes in their journal article. We recommend the use of a software tool such as [EndNote](#) or [Reference Manager](#) for reference management and formatting.

**Abstract:** Please send a one-paragraph (200-250 words) abstract with your article for inclusion on the publisher's website.

**Key words:** Please provide five or six keywords for the website.

**E-proofing:** Proofs are sent to authors as a PDF file. When the proof is ready, authors receive an email containing a link to the website on which they can download the PDF and find instructions on how to correct the proofs. Proofs must be returned to the Journal at the above address or by fax or e-mail within the number of days indicated. Authors are reminded that only corrections to printer's errors should be made. Rewriting of material originally submitted will be disallowed at the editors' discretion. Please contact Christina Keyes ([eje@dauphine.fr](mailto:eje@dauphine.fr)) if you find any major problems.

**Author's copy:** Authors receive one copy of the Journal in which their article is published, as well as the article in a PDF format as soon as the issue appears on the publisher's website. The e-mail to which the PDF is attached contains the Guidelines for Usage, setting out rights to distribute the PDF on a non-commercial basis.

**Copyright Transfer Agreement:** Authors will be required to sign a Copyright Transfer Agreement (CTA) for all papers accepted for publication. Signature of the CTA is a condition of publication and papers will not be passed to the publisher for production unless a signed form has been received. After submission authors will retain the right to publish their paper in various media/circumstances (please see the form for further details). To assist authors an appropriate form will be supplied by the editorial office.
