GUIDELINES FOR CONTRIBUTORS

The Editors welcome scholarly papers on **all aspects of clinical nursing and midwifery**, including management, teaching and research related to practice. All manuscripts are double blind refereed. Submission should be exclusively to the Journal of Clinical Nursing and authors will be asked to sign a statement confirming that they have conformed to the normal ethical aspects of investigation and copyright.

Authors will be asked to provide both disk and hard copies of the final accepted manuscript. The Editors will decide on the time of publication and retain the right to modify the style of a contribution; major changes will be agreed with the author(s).

Manuscripts

Three copies of the manuscript, tables and figures should be submitted. Papers should be between 3000 and 5000 words in length, typed on one side only of A4 paper or international equivalent using double spacing and a wide margin on each side of the text. The numbers of words used, excluding references, should be specified. Details of sources of research funding, other support, and acknowledgements should be included.

The top sheet should display the manuscript title, and a shortened version, authors' names, professional and academic qualifications, positions and places of work and the address to which all correspondence and proofs should be addressed. Email addresses should also be given wherever possible.

Figures, illustrations, legends, tables, references and acknowledgements should be prepared on separate sheets. Their appropriate insertion points should be indicated in the text margin. Approval for reproduction/modification of any material (including figures and tables) published elsewhere should be obtained from authors/copyright holders before submission of the manuscript. Contributors are responsible for any copyright fee involved.

The text should be **preceded by a short summary, using bullet points** and not exceeding 300 words. In the case of reported empirical research, the summary should include as appropriate: the study's rationale, aims and objectives; methodological design and justification; ethical issues and approval; research methods, instruments and/or interventions; outcome measures; results; study limitations; and conclusions. The summary should not include references or abbreviations. The summary should be followed by up to **6 keywords** which accurately identify the paper's subject, purpose and focus.

Critical reviews of literature on any area of research of relevance to clinical nursing are invited for the **Review Articles** section of the journal. Submissions should not exceed 5000 words in length and should be structured under appropriate headings so that the aims, scope and comprehensiveness of the review are clear. **The search strategy** should be described. **Both positive and negative critique** should be included.

The **Research in Brief** section is intended for short reports. These should include the aims and objectives of the work reported, methods used, findings, and implications for practice, management, education and further research (where appropriate). Research in Brief submissions should be approximately 500 words in length, with a clear but concise title and three to four subheadings. A maximum of three references may be included. Line drawings and one table may be included. **Headings** within the text should conform to the following convention: upper case for main headings, lower case for major subheadings, italics for subsidiary subheadings.

Spelling should conform with that used in The Concise Oxford Dictionary and abbreviations with those in Units, Symbols and Abbreviations (1994) published by the Royal Society of Medicine Press, 1 Wimpole Street, London W1M 8AE.

Abbreviations should be used sparingly and only if a lengthy name or expression is repeated throughout the manuscript. When used, the abbreviated name or expression should be cited in full at first usage, followed by the accepted abbreviation in parentheses.

Quotations included appropriately within the body of the text should be marked by single inverted commas. Longer, or self-contained quotations should be preceded and followed by a double space; neither single inverted commas nor italics should then be used.

Statistical methods used should be defined and, where appropriate, supported by references.

Final accepted manuscripts should be supplied on **disk and in hard copy form**. If the two versions of the manuscript do not correspond, the disk version will be used.

References

All work referred to in the manuscript should be fully cited. References **within the text** should cite the authors' names followed by the date of publication, in date order, e.g. (Lewis, 1975; Barnett, 1992; Chalmers, 1994). Where there are three or more authors, the first author's name followed by et al. will suffice, e.g. (Barder et al., 1994), but **all authors should be cited in the reference list**. **Page numbers** should be given in the text for **all quotations**, e.g. (Chalmers 1994 p. 7). All references should be cited from **primary sources**.

When **a paper** is cited, the reference list should include authors' surnames and initials, date of publication, title of paper, name of journal in full (not abbreviated), volume number (and issue number where relevant), and first and last page numbers. Example: Barder L., Slimmer L. & Lesage J. (1994) Depression and issues of control among elderly people in health care settings. *Journal of Advanced Nursing* 20, 596-604.

When **a book** is cited, the title should be stated, followed by the publisher and town, county/state (and country if necessary) of publication. Example: Dealey C. (1994) *The Care of Wounds: A Guide for Nurses*. Blackwell Science, Oxford.

Where the reference relates to **a chapter in an edited book**, details of author and editors should be given as well as publisher, place of publication, and first and last page numbers. Example: Chalmers K.I. (1994) Searching for health needs: the work of health visiting. In *Research and its Application* (Smith J.P. ed.), Blackwell Science, Oxford, pp.143-165. The edition (where appropriate) of all books should be identified, e.g. 2nd edn.

References stated as being 'in press' are not acceptable: all references cited must have been published by the page proof stage of the paper. **The reference list** should be prepared on a separate sheet and be in alphabetical order and chronological order by first authors' names.

Illustrations

We would like to receive your artwork in electronic form. Please save vector graphics (e.g. line artwork) in Encapsulated Postscript Format (EPS), and bitmap files (e.g. half-tones) in Tagged Image File Format (TIFF). Ideally, vector graphics that have been saved in metafile (.WMF) or pict (.PCT) format should be embedded within the body of the text file. Always enclose a hard copy of figures and label with the figure number.

Proofs will be sent to the author submitting the paper and must be returned promptly. This will allow correction of printers' and similar errors. Major changes will not be entertained and authors may be charged for excessive amendments at this stage.

Twenty-five **offprints** will be supplied free for each paper published; further offprints may be ordered when returning proofs.
