# Journal of Forensic Nursing

The International Association of Forensic Nurses (IAFN) is seeking an editor to provide the editorial leadership for its flagship publication, the *Journal of Forensic Nursing (JFN)*, which is published quarterly on behalf of the Association by Wiley-Blackwell. Now in its 5th year of publication, *JFN* is a groundbreaking journal that covers all facets of this multidisciplinary specialty: health care, law enforcement, legal issues, and forensic science.

#### An Overview of the Position:

The editor will be responsible for the overall visionary leadership to ensure that *JFN* builds on its objective to publish scholarly manuscripts and to expand empirical evidence important to the practice of forensic nursing worldwide. ### Major Responsibilities:

  - Identify and facilitate critical partnerships with key global players in nursing to increase the dissemination of the journal and its content.
  - Decide on the content of each issue and ensure the delivery of the journal is fully coordinated with the strategic directions and priorities identified by the IAFN.
  - o Invite, orient, and oversee an international editorial board and panel of reviewers.
  - Oversee the peer-review process for regular articles and column submissions with the editorial assistant using Manuscript Central.
  - Prepare and submit an annual report on editorial activities, current status of and future plans for the journal to the IAFN.

## Qualifications:

- Communication and Leadership skills.
- Excellent record of publication in leading peer-reviewed nursing and healthcare journals.
- Keen understanding, based on academic and clinical experience, of the current state of forensic nursing research, areas of
  greatest need for additional research, and clinical implications of research.
- Excellent understanding of the importance of forensic nursing research as it supports and enhances nursing practice.
- Solid editorial and peer review experience in forensic nursing research and scholarship.
- Established relationships with nursing and healthcare leaders and institutions globally.
- Academic credentials (PhD desired, Master's required).

The transition of the editors will start on or around May 1, 2009, with the full term commencing January 2010.
