NOTES FOR SUBMITTING SUPPLEMENTS TO ALIMENTARY PHARMACOLOGY & THERAPEUTICS

- All papers should be submitted on-line at http://mc.manuscriptcentral.com/apt
- If you do not have an account within the website, please click on the "Create Account" tab at the top right-hand side of the screen.
- The papers for the supplement can all be submitted together under one submission, including the Introduction (if applicable).
- Please select "Supplement paper" as the Manuscript type.

The preferred style for most Supplements to AP&T is that all the papers are integrated to provide one large paper, with multiple Authors – very much in the style of AP&T Volume 29 Issue s1, Pages 1 - 49 (May 2009)

- When submitting the manuscripts, you will need to know the name, full postal address, telephone, fax and importantly e-mail address for the corresponding Author.
- The full name, institution and e-mail address are also required for each additional Author.
- The Summary for the complete supplement must be no more than 250 words and must be structured under all of the following headings: *Background*, *Aim*, *Methods*, *Results*, *Conclusions*. .
 - Each additional paper within the supplement should also contain a Summary but these do not need to be structured as above, and should be no more than 75-150 words.
- Reviewers the nomination of 2 potential reviewers is optional. Please enter the first name, last name and e-mail address of two potential reviewers. These may/may not be used during the reviewing process.
- If colour figures are included in the submitted papers, please indicate whether you wish these to be
 published in colour if yes, then the Supplements Production Team will contact you directly as these costs
 will be additional to those quoted for the supplement. Please therefore ignore the instruction on the
 submission website to download and complete the Colour Work Agreement form.
- Statement of Interests this section is mandatory during the submission process and <u>must</u> be completed for each Author of the manuscript. The same information must also be included at the end of the submitted manuscript under a separate heading "Statement of Interests" please see below.

If financial support was received for this study please read the following statements, adding those parts which are relevant in both this section and also at the end of your submitted manuscript under a heading "Statement of Interests".

1. Authors' declaration of personal interests:
