Authors	Manuscript (title page) & online submission	Names (initials followed by surname), department, and institution of all authors Original submissions will need to be accompanied by an author consent form which confirms that all listed authors meet ICMJE authorship criteria and that nobody who qualifies for authorship has been excluded. Authorship credit should be based on 1) substantial contributions to conception and design, acquisition of data, or analysis and interpretation of data; 2) drafting the article or revising it critically for important intellectual content; and 3) final approval of the version to be published. Reporting guidelines	Online submission	Manuscripts reporting RCTs are required to follow CONSORT guidelines. Manuscripts reporting observational studies are required to follow STROBE guidelines. Word count	Manuscript (title page)	Manuscript word count (excluding figure/table legends and references)	<input type="checkbox"/>
Abstract	Manuscript	Authors submitting original articles and concise communications should note that structured abstracts are required. The structured abstract should adopt the format: Background, Objectives, Methods, Results, Conclusions. Reviewers	Online submission	We strongly encourage authors to supply the names of two preferred reviewers; this will facilitate the efficient and swift review of manuscripts.	<input type="checkbox"/>
Supplementary material	Online submission	The <i>BJD</i> encourages the submission of underlying datasets, appendices, movie files, etc. as online-only "Supplementary files for review". Completed CONSORT/STROBE checklists must be submitted as "Supplementary files for review" Completed Exclusive Licence and Author Consent Forms must be submitted as "Supplementary files not for review"	<input type="checkbox"/>
Online Open	Post submission	Optional. Online Open is available to authors of articles who wish to make their article available to non-subscribers on publication, or whose funding agency requires grantees to archive the final version of their article.
